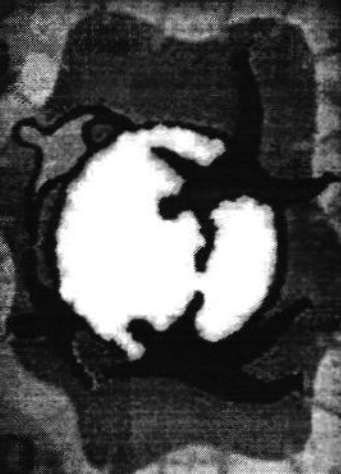

Why

"THE INTERNATIONAL OMBUDSMAN"?

Considering the more and more complex and articulate system of the Public Administration (international, national and territorial), many citizens don't know to whom they may apply for the protection of a right or to be helped in case of need.

THE INTERNATIONAL OMBUDSMAN is the **AUXILIARY HELPER** for every citizen of all over the world:

- both where the Ombudsman was appointed and where not yet;
- both in the specific case of maladministration and as a promoter of necessary administrative reforms for the citizen's protection.

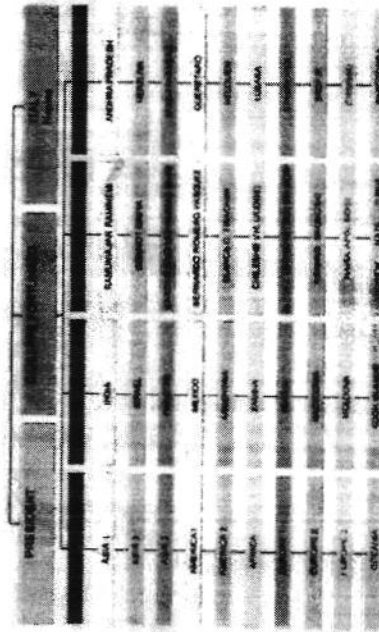
What is "THE INTERNATIONAL OMBUDSMAN"?

The International Ombudsman is a collective body made up of Ombudsmen, to whom any citizens can apply for any case of maladministration. The International Ombudsman will send the case to the local competent Ombudsman, otherwise it will act directly. The International Ombudsman promotes the Ombudsman institution in every country. The International Ombudsmen, whose members are only Ombudsmen, co-operates with every institution involved in the citizen's protection. The International Ombudsman safeguards the "Ombudsman" denomination.

Who is member of "THE INTERNATIONAL OMBUDSMAN"?

Members of "The International Ombudsman" are only the Ombudsmen carrying out this office, that have general competence (excluding similar institutions with special or limited competences or involved in particular fields) and that are independent institutions separated from Parliaments or elective assemblies (excluding presidents or members of parliamentary or regional or territorial committees or those who are members of parliament, of regional or territorial elective assemblies or in any case politicians, even if they carry out the duties of examination of the petition and of protection of the citizen's civil rights).

THE INTERNATIONAL OMBUDSMAN supports the collaboration with other institutions involved in the protection of the citizen but reserves this enrollment only to the Ombudsmen, who must be:

- Ombudsmen, who hold the office (excluding collaborators and experts involved in the offices or in the work of ombudsmen);
- Ombudsmen, in general (excluding institutions with competences in limited fields or classified as "Special Ombudsmen");
- Ombudsmen, independent institutions and separated from the Parliament and from the regional or territorial representative institution (excluding Committees or parliamentary committees and Committees or Commissions of regional or territorial assemblies and, in any case, politicians).
